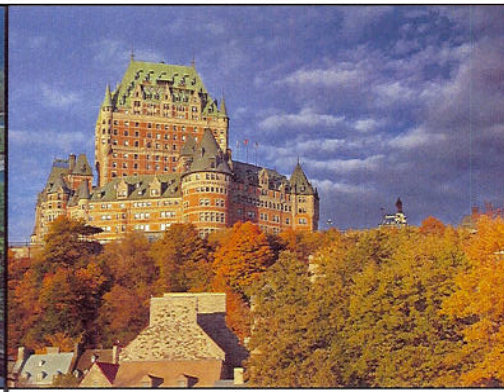

### Day 2: Montreal City Tour

### Day 3: Montreal - Rail Journey - Quebec City

This morning board **Via Rail Canada** for the scenic and relaxing train ride to the "Paris of North America," **Quebec City**. Carved into the bluffs overlooking the St. Lawrence River, Quebec City is the provincial capital and probably the best preserved city in North America. Upon arrival a short drive takes you to **Montmorency Falls**, the highest falls in Eastern Canada--98 feet higher than Niagara Falls. Dinner is included this evening.

### Day 4: Quebec City Tour

Today enjoy a **Quebec City Tour** introducing you to Old & New Quebec, North America's only walled city. The tour features the **Plains of Abraham**, the famous **Le Chateau Frontenac** and **The Citadel**. Quebec City was once the center of New France and has been the focal point of French and British battles for generations. Here the residents are French Canadian from their food and customs to their language and way of thinking. The afternoon is at leisure to explore this great

Canadian city on your own.

### Day 5: Quebec City - Ottawa

Today travel along the banks of the St. Lawrence River, a route used by early French explorers and fur traders, to Canada's stately capital city, **Ottawa**. This afternoon enjoy an **Ottawa City Tour** to see the Parliament Buildings located high above the Ottawa River on historic **Parliament Hill**, the **Supreme Court**, the Prime Minister's residence, the War Memorial, the Peace Tower, **Byward Market & Rideau Canal**.

### Day 6: Ottawa - Toronto - Niagara Falls

After breakfast depart Ottawa and travel to cosmopolitan Toronto. Upon arrival enjoy a panoramic **Toronto City Tour** featuring the modern downtown area, **Yorkville**, the **University of Toronto** and the **Provincial Parliament**. This evening arrive in spectacular **Niagara Falls** for a two night stay.

### Day 7: Niagara Falls Touring

Today discover **Niagara Falls**, divided into the Canadian & American Falls by **Luna and Goat Islands**. ### CANCELLATION WAIVER & POST DEPARTURE PLAN

Payment of the per person Cancellation Waiver (waiver fee) guarantees full refund on all payments (including deposit), except the waiver fee itself, made for tour rates in case of cancellation up to the time & date of departure due to passenger's personal illness (medical documentation required) or death of a member of the immediate family (official documentation required). If the passenger must return early due to passenger's personal illness or death of a member of the immediate family, payment of the waiver fee guarantees a refund for the unused services. Payment of the waiver fee guarantees your return air transportation utilizing your original airlines tickets with no additional supplement. The waiver does not cover return transportation costs other than return air transportation utilizing original airline tickets. The waiver fee is fully refundable until 180 days prior to departure. **The waiver fee does not cover any single supplement charges which arise from an individual's traveling companion electing to cancel for any reason prior to departure.** The waiver is non-transferable and valid for each applicant only. The waiver does not cover any services such as airline tickets not purchased through Premier World Discovery. Post Departure coverage (Accident & Medical) is included. ### CANCELLATION FEES

Cancellations not covered by the waiver or if the waiver is not purchased, are subject to the following per person fees:

- Cancel more than 180 days prior to departure: Full Refund
- Cancel 179-75 days prior to departure: Deposit or Waiver is Retained
- Cancel 74-45 days prior to departure: 25% of total price
- Cancel 44-15 days prior to departure: 50% of total price
- Cancel 14 days or less prior to departure/no shows: No refunds

**Final payment is due 75 days prior to departure.**
